# SAFETY

**Prop 1 should protect pregnant people from criminalization for ALL pregnancy outcomes!**

**Under Prop 1, discrimination based on pregnancy status, pregnancy outcomes, & reproductive health care count as "sex discrimination" and are forbidden!**

**And yes! Prop 1 protects abortion at any point in pregnancy.**

**(currently federal and NY state constitutions do NOT protect against pregnancy discrimination)**
