SAFETY!

Prop 1 should protect pregnant people from criminalization for **ALL** pregnancy outcomes!

Under Prop 1, discrimination based on pregnancy status, pregnancy outcomes, & reproductive health care count as "sex discrimination" and are forbidden!

And yes! Prop 1 protects abortion at any point in pregnancy.

(currently federal and NY state constitutions do **NOT** protect against pregnancy discrimination)
